### **Statistics and Google Analytics**

We keep statistics on the use of our website.

We use Google Analytics to keep track on our visitor usage of our website. We have a data processing agreement with Google, in this agreement strict arrangements are made with Google on what they are allowed to track. We **do not** allow Google to use the gained analytical information for other Google services. We let Google anonymize all IP addresses.

### **Safety is our priority**

Security of personal data is of foremost importance to us. We take the following measures to protect your privacy.

- We keep logs of all requests of personal data.

- We use secured connections (Secure Sockets Layer or SSL) when you enter your personal data on our website to guard all information between you and our website.
